Reliability or Security Risks Identified

- There have been several WIT Schedule Change requests due to dynamic ETSR errors
 - This creates false inadvertent in real-time, as the Primary Inadvertent Interchange and Automatic Time Error corrections are paid in-hour for two hours prior
 - These errors result in incorrect payback in that hour, that ends up being corrected later which causes generators to pay back energy in a delayed timeframe
- Concerns expressed within ISAS and ATFWG moving to a Forum under RRC and the loss of subject matter expertise
