

## **Western Renewable Energy Generation Information System (WREGIS) Assignment of Registration Rights**

### **1. General Acknowledgements and Representations**

- 1.1 WREGIS does not determine who has legal title to Generating Units or Certificates, and this Assignment is only intended to provide WREGIS with information regarding how the parties wish to assign registration rights in WREGIS.
- 1.2 For Generating Unit(s) designated on Attachment 1, all Generator Owners must be listed in the attachment.
- 1.3 The Generating Unit(s) covered under this Assignment are not covered by any other Assignment not yet terminated in WREGIS or any other certificate tracking system.
- 1.4 Assigned Customer will pay all fees associated with the generator and related WREGIS certificates.

### **2. Change and Termination of Assignment**

- 2.1 All parties to this Assignment have a duty to notify WREGIS if or when any information in this Assignment ceases to be truthful, accurate, or complete. Until WREGIS receives a written and signed notification of a change in this Assignment, or until the Assignment is terminated in accordance with this section 2, WREGIS will rely on this Assignment as governing its relationship with the Generating Unit and assigned Customer. Any written notice of changes to this should be provided to WREGIS at least 15 business days in advance of the date upon which such changes are to become effective. Changes will be effective on



the date requested by the parties, or upon issuance of written acknowledgement by WREGIS, whichever is later.

- 2.2. All parties to this assignment may terminate this Assignment at any time by providing the WREGIS Administrator written notice that the assignment has been terminated and is no longer in effect.
- 2.3. Termination of this Notice will be effective the date identified in the notice of termination, or upon issuance of written acknowledgement by WREGIS, whichever is later.
- 2.4. Immediately upon termination, the Generating Unit covered by this assignment will be put into inactive status until such time it can be transferred to another WREGIS Customer.

### 3. Waiver

Nothing in this Notice shall be construed to create or give rise to any liability on the part of WREGIS or WECC. This Notice shall not be construed to modify any terms or conditions of the WREGIS Terms of Use or Operating Rules, and in the event of conflict between this Assignment and the WREGIS Terms of Use or Operating Rules, the Terms of Use or Operating Rules shall control.

Parties execute this Assignment to be effective as of the date written above or upon issuance of written acknowledgement by WREGIS, whichever date is later. Parties each affirm, that they have participated in the preparation of this Assignment, and that the information provided herein is true, correct, and complete, to the best of their knowledge and belief.
