Subject: Member Advisory Committee Class 4 Nomination

Dear Class 4 Member Representative,

The Member Advisory Committee (MAC) serves an important role in advising the WECC Board of Directors (Board). MAC responsibilities include giving timely updates and communications to the membership, helping to select Board of Director candidates, setting Board Director compensation, developing a work plan that includes consideration of issues identified by the Board and the MAC, drafting the agenda for the Annual Member Meeting, and representing the interests of their member classes as the MAC considers issues.

The MAC is seeking nominations for a Class 4 representative. One position will be open for election—the seat currently held by **Fred Heutte**. The Class 4 MAC representatives whose terms are not up for election this year are **Michele Beck** and **Sophie Hayes**.

For nominating and electing MAC members, the MAC Charter requires that:

- Only members of each class may nominate and vote on candidates for election as MAC member representatives for their respective class.
- A class candidate need not be a member of the class, nor an employee of a class member.
- A quorum (constituting a majority of the members of a class) must be achieved to elect a MAC member for the class; election shall be by simple majority of votes cast.

In accordance with these requirements, please submit any nominations for a Class 4 MAC representative. Each nominee must complete, sign, and date the attached Candidate Statement of Qualifications (CSQ). The Nomination and Election Process is as follows:

- Wednesday, July 30, 2025—Final submissions due
- Thursday, July 31, 2025—Slate of nominees will be posted on WECC.org Announcements page and sent via WECC Weekly
- Monday, August 4, 2025—Ballots sent to Member Representatives
- Friday, September 5, 2025—Voting concludes
- Wednesday, September 18, 2025—Election results will be announced at the Annual Members Meeting.
