WECC has released the [2025 State of the Interconnection](#). This annual report provides a high-level look at reliability issues throughout the Western Interconnection over the recent past and near future. This year's report reveals significant growth in generation capacity and an increase in physical security incidents. It also examines load growth in the recent past, provides a look at extreme natural events that took place across the interconnection in 2024 and how the entities contended with them, and gives insight into several significant transmission projects underway throughout the West.

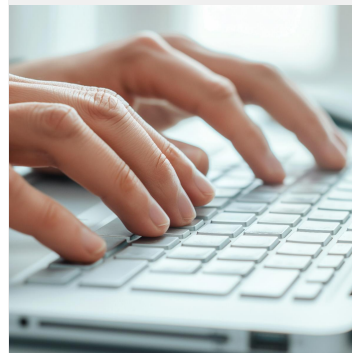
Stakeholder Comment Period—WECC Bylaws ^{NEW}

WECC's Section 4.9 Review Work Group has engaged in a comprehensive review of WECC's Bylaws to ensure that they continue to align with WECC's purpose as a Regional Entity under Section 215 of the Federal Power Act. A draft of the proposed revised Bylaws is now available for stakeholder review and [comment](#) until the close of business on June 20, 2025. To facilitate stakeholder review and comment, the Section 4.9 Work Group has prepared a [table](#) summarizing the most significant proposed revisions.
