

ASSURANCE PROGRAM

The Assurance Program provides WECC and its stakeholders with tools to help manage specific risks. Managed by WECC staff, the program is designed to help entities across the Western Interconnection refine their approach to risk mitigation by sharing best practices and lessons learned.

The program is designed to ensure registered entities are aware of the resources available to assist with risk mitigation efforts (e.g., Small Group Advisory Sessions (SGAS), reports from past extreme weather events, lessons learned, Reliability Guidelines, Implementation Guidance, etc.). Through this effort, WECC will recommend improvements to policies, processes, and procedures, while reviewing risk mitigation efforts by registered entities within the Western Interconnection.
