1. Welcome, Call to Order

6. Endorse Long-Term Planning Task Force Charter

Ms. Loomis presented the Long-Term Planning Task Force Charter (LTPTF) for endorsement. The JGC clarified that the LTPTF's purpose and responsibilities will be to develop models and data sets. The Reliability Assessment Committee (RAC) will be notified of the endorsement.

On a motion by Eric Baran, the JGC endorsed the LTPTF Chater with the understanding that the task force's purpose and responsibilities will be to develop models and data sets.



7. Leadership Training Survey Discussion

Branden Sudduth, JGC Co-Chair, presented the Leadership Training Survey Results. The JGC discussed utilizing the feedback for future training and integrating more of the three-year work plan's purpose and other elements of leadership into the training.

8. Reliability Risk Priorities Process Update

Ms. Ravenscroft presented the Reliability Risk Priorities (RRP) update and timeline. The RRP's are being reviewed and will align with the WECC Risk Register but the same ranking system will not be used. The RRP Workshop will be February 29, 1:00 to 4:00 p.m.

9. JGC Year Ahead

Mr. Sudduth led the discussion regarding the JGC's plans for the year.

The JGC agreed to work on the following tasks:

- Review the strategic alignment process moving forward;
- Review the JGC's role with the three-year work plan, along with the RAC and RRC's coordination;
- Discuss if the JGC's Charter requirement to evaluate one-third of the committees and review if is needed;
- Discuss WECC Board's assignment for the JGC to review the process of the committees;

- Evaluate the JGC purpose, role, and the value that it is providing, along with reviewing if the JGC's assigned tasks are still needed.

The JGC discussed if it's necessary to continue meeting monthly. An agreement was made that the JGC Leadership will assess two weeks prior to the regular scheduled meeting to see if there is a purpose in holding the upcoming meeting. The JGC also discussed looking into an inperson meeting during 2024.
