External stakeholder groups include federal agencies, joint ventures, trade organizations, and key vendors.

This included the design and implementation of an organizational model to improve execution capability, enhance collaboration, enable scalability, and provide opportunities for cross-killing and up-skilling; and the adoption of Lean Portfolio Management and Agile methodologies to drive efficacy and efficiency in value delivery. Includes cybersecurity governance review framework and processes; cybersecurity governance reviews embedded into software product development and procurement processes; joint risk acknowledgement by business owners, IT, and Legal with defined levels of authority; and regular tracking and reporting of cyber risks. Resulted in cyber risk management being institutionalized within the company.

Collaborated with the Legal Department to establish a formal governance structure and create a cross-functional executive council, consisting of senior/VP-level executives, that govern the areas of information security, data privacy, and records and information management.
