

- Final Ballot Results for Project 2023-07—Transmission Planning Performance Requirements for Extreme Weather
 - TPL-008-1 Passed with 84.08% quorum and 75.43% Approval
- Comment and Ballot Period for Project 2024-03—Revisions to EOP-012-2
 - Both the comment and ballot period for this project end 12/20/2024



WECC Standards, Variances, Criteria

- WECC-0142: Request to Retire BAL-002-WECC-3, Contingency Reserve
 - Posting 1 for Comment is open through 01/15/2025
- WECC-0156: VAR-001-5 Voltage and Reactive Control Modification to the WECC Regional Variance
 - Changes to NERC Registration Criteria driving the update
 - WSC approved the SAR at the 11/25/2024 meeting
 - Will be Soliciting for Drafting Team members in January 2025

Upcoming SARs and Engagement

- A SAR for the PRC-006-5 Automatic Underfrequency Load Shedding WECC Variance is in the works
 - Reviewing for potential gaps
- Reliable IBR Integration and Milestone 3 of FERC Order no. 901 Technical Workshop

2024 Program Enhancements and Achievements

- From 11 Registered Entities approved on January 1, 2024, to 24 Registered Entities including confirmed approvals, with two pending applications
 - 11 formal applications filed in 2024
- Prioritization of self-logged PNCs to disposition and filing
- Improved feedback and communication
- Reduced need for RFIs and strengthened Self-Reports and Self-Logs across the board in conjunction with Enforcement Fundamentals course



ERO Enterprise Alignment

- ERO Enterprise alignment and standardization of Self-Logging application criteria and evaluation
- ERO Enterprise alignment of joint-evaluations and criteria for trainings
- Creation of Evaluation Checklist document for consistent analysis of criterion across Regional Entities
- Continued enhancement of procedures and updating guidance documents
- Continued discussion regarding current and proposed benefits of the program


- Expanded team with additional Engineers and Attorneys
- Double Pac-Man to focus on aged and new
- New cases processed closer to real time
- Focused, risk-based processing
- Significant focus on entity outreach with Enforcement Fundamentals Training

2024 Enforcement Processing

- 102 aged cases (44% reduction)
- 174 new cases (50% of intake)
- Average processing time for new cases:
 - Self-logged CEs, 2 months
 - Non-self logged CEs, 5 months
 - FFTs, 6 months

Enforcement Fundamentals

- WECC Enforcement Fundamentals training prepares Registered Entity staff to resolve noncompliance with Reliability Standards.
- Enforcement held six training sessions in 2024 at Registered Entity locations throughout the west.
- Over 200 people from more than 75 Registered Entities participated.



- Zero-defect, periodic activity, or phased-implementation requirements frequent source of Self-Reports/Self-Logs
- Timely detection and remediation key to risk mitigation
 - CIP-007-6 R2, CIP-010-4 R1
 - MOD-025-2 R1/R2, PRC-005-6 R3
