1. Welcome, Call to Order

Chris Leyerle, WREGIS SAC Chair, called the meeting to order at 11:01 a.m. MT on November 12, 2024. A quorum was present to conduct business. A list of attendees attached as Exhibit A.

2. Review WECC Antitrust Policy

Andrea Coon read aloud the WECC Antitrust Policy statement.

5. WREGIS Staff—Updates

Andrea Coon informed,

- e-Tags
 - Compliance and transfer issues are resolved.
- WREGIS is working on remainders' issues not related to compliance.
 - WREGIS will continue with weekly releases focused on remainders' issues for generators with a difference of less than five RECs.
- In person training held in Salt Lake City on November 7, 2024, was a success.
 - WREGIS plans to schedule one or two web-based training sessions before the end of the year.
 - WREGIS plans to hold in-person trainings throughout 2025, as well as web-based trainings in the first quarter of 2025. WREGIS will send announcements.
- WREGIS is holding conversations with other entities to track nuclear energy in the system.
 This fuel type is not renewable energy, the tracking will be based on clean energy parameters and will begin registering in WREGIS within a three to six-months.

Todd Jones, Center for Resource Solutions (CRS), discussed a letter from CRS dated November 7, 2024, previously delivered to SAC members. He answered questions and clarified points to SAC members regarding CRS's position on proposed accounting frameworks of California Independent System Operator (CAISO), and Southwest Power Pool (SPP). If SAC members need more information, the letter contains links to specific information.

Daniel Sadik, Carbon Solutions Group, informed the SAC on a rule issued by the California Air Resources Board (CARB) regarding Low Carbon Fuel Standard (LCFS) and distributed generation (DG) (generation from residential and small commercial type generating units). Mr. Sadik proposed that the SAC cover this in the next meeting.
