An independent WREGIS will:

- Enable WREGIS stakeholders, through a hybrid board and a strong stakeholder advisory committee, to participate fully in key decisions affecting the WREGIS system
- Allow WREGIS to focus solely on providing an excellent software product and outstanding service
- Provide stakeholders with a more impactful voice by allowing more input and influence over future software enhancements
- Include WREGIS stakeholders in the selection of its board members

software development is complete and functional**

- ☐ How will the board interact with the Stakeholder Advisory Committee?

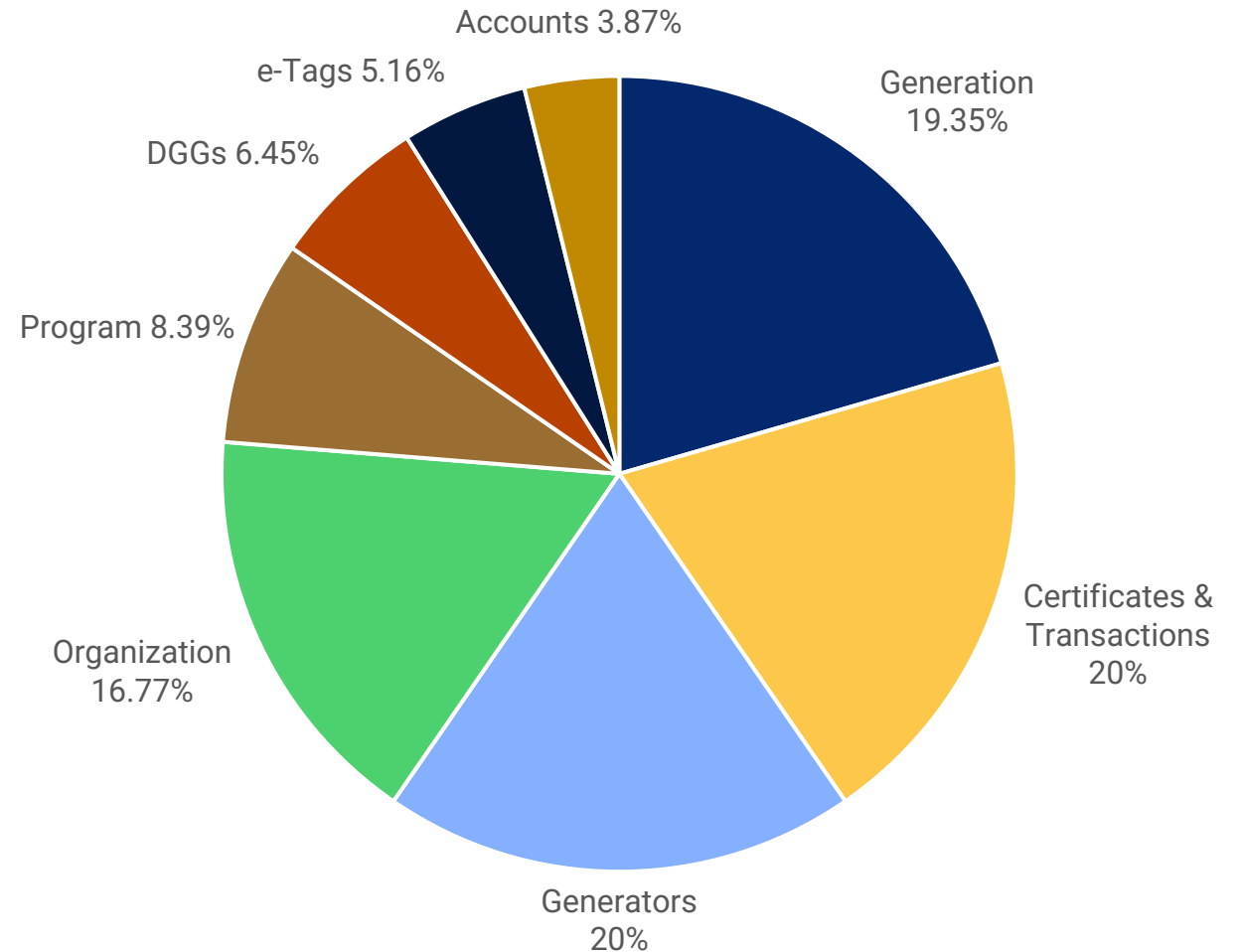
Stakeholder Advisory Committee

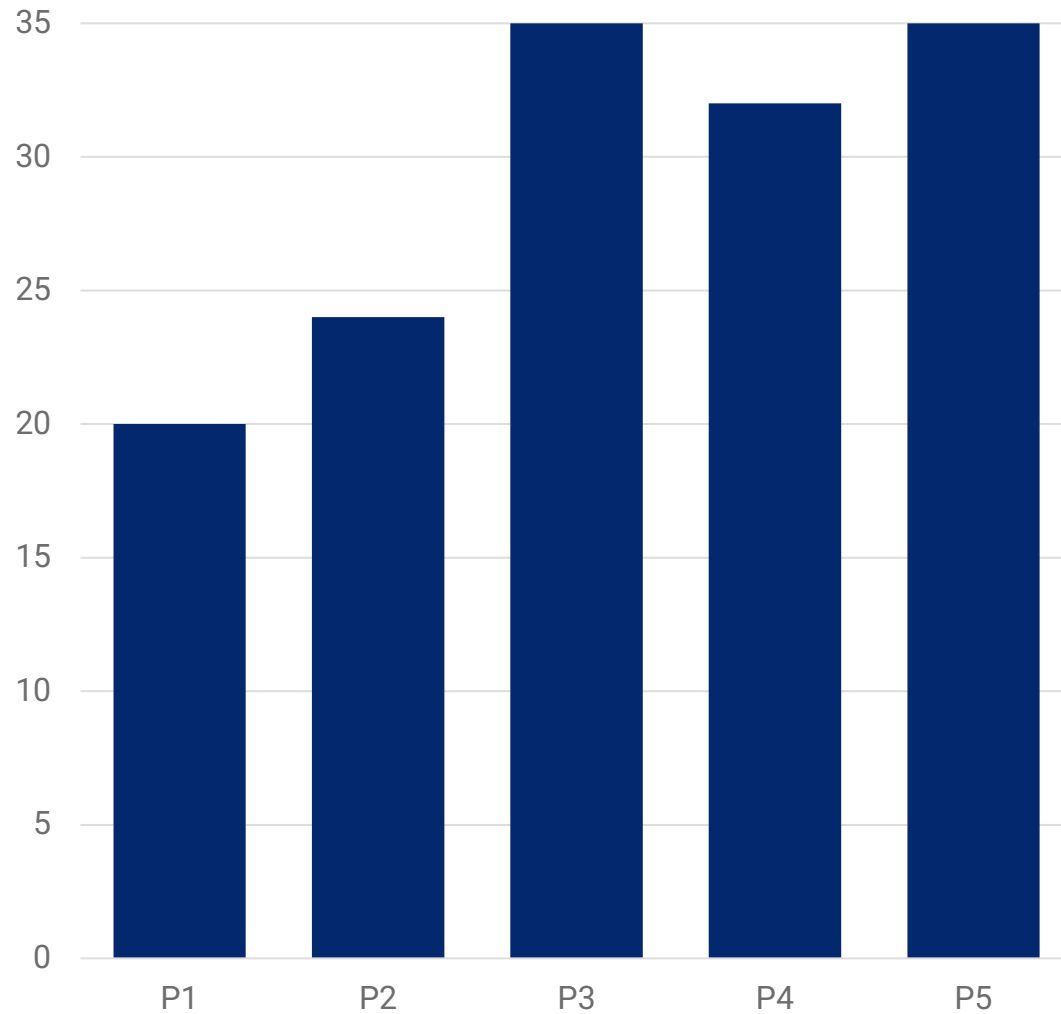

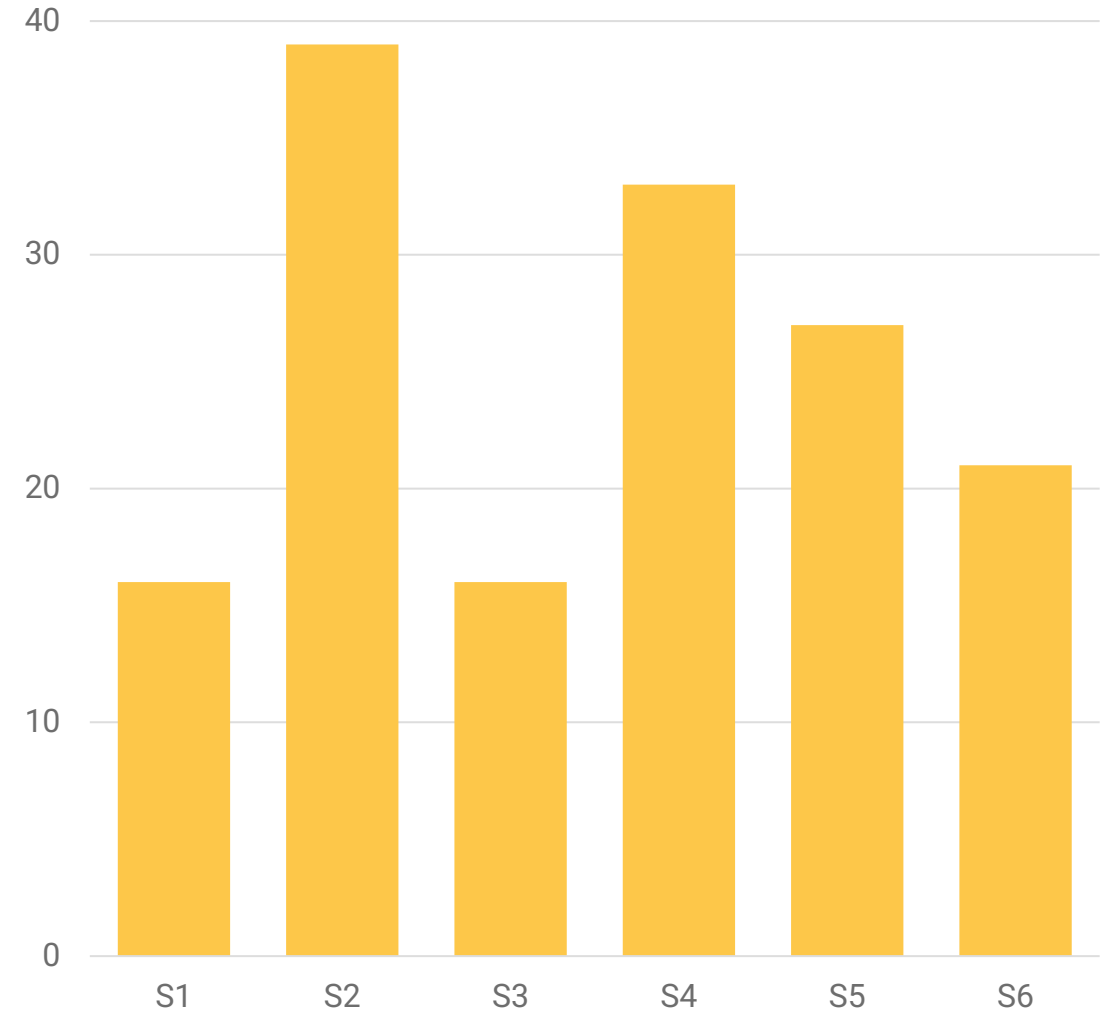


Tickets by Priority and Severity

Tickets by Priority

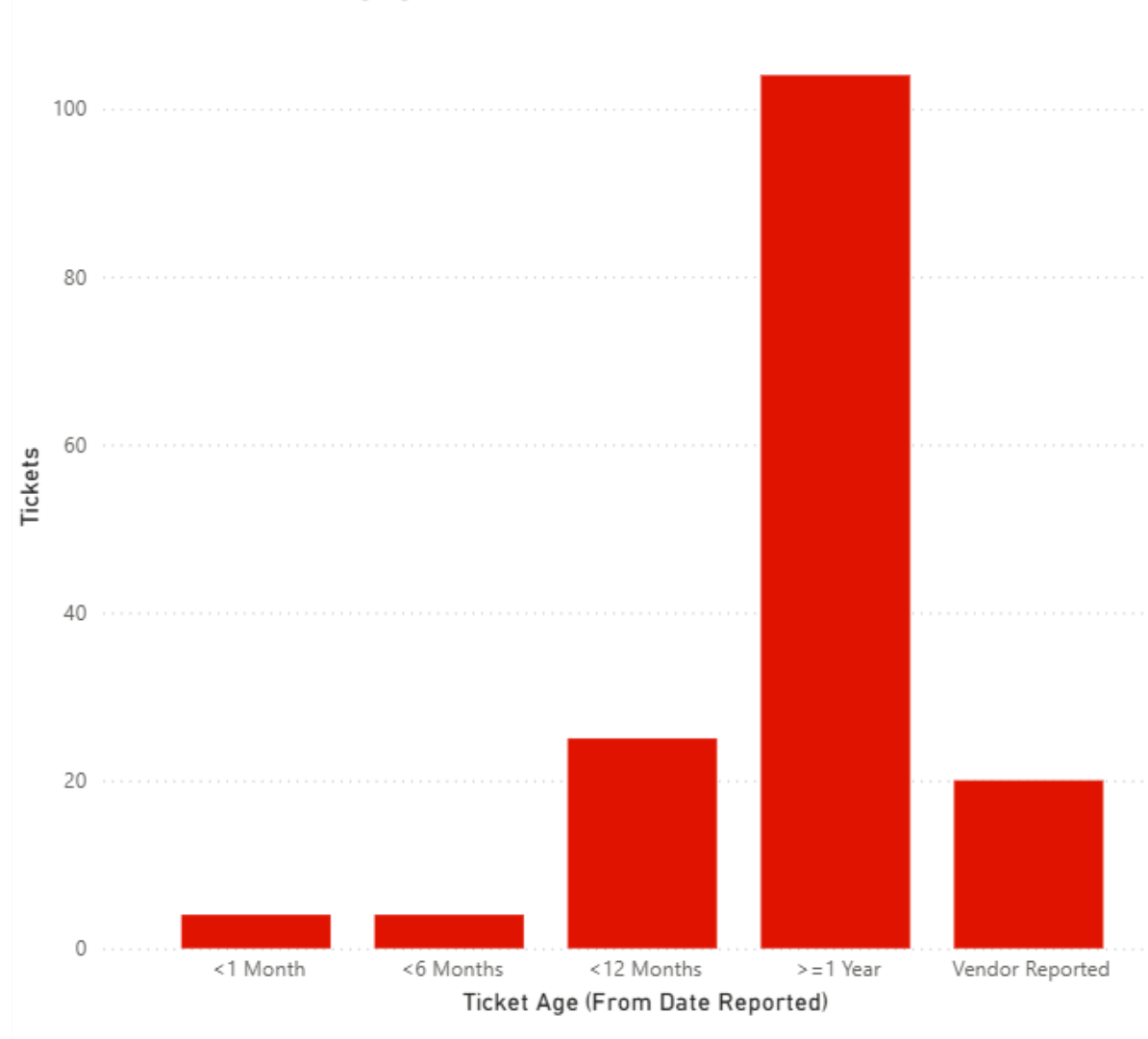


Tickets by Severity

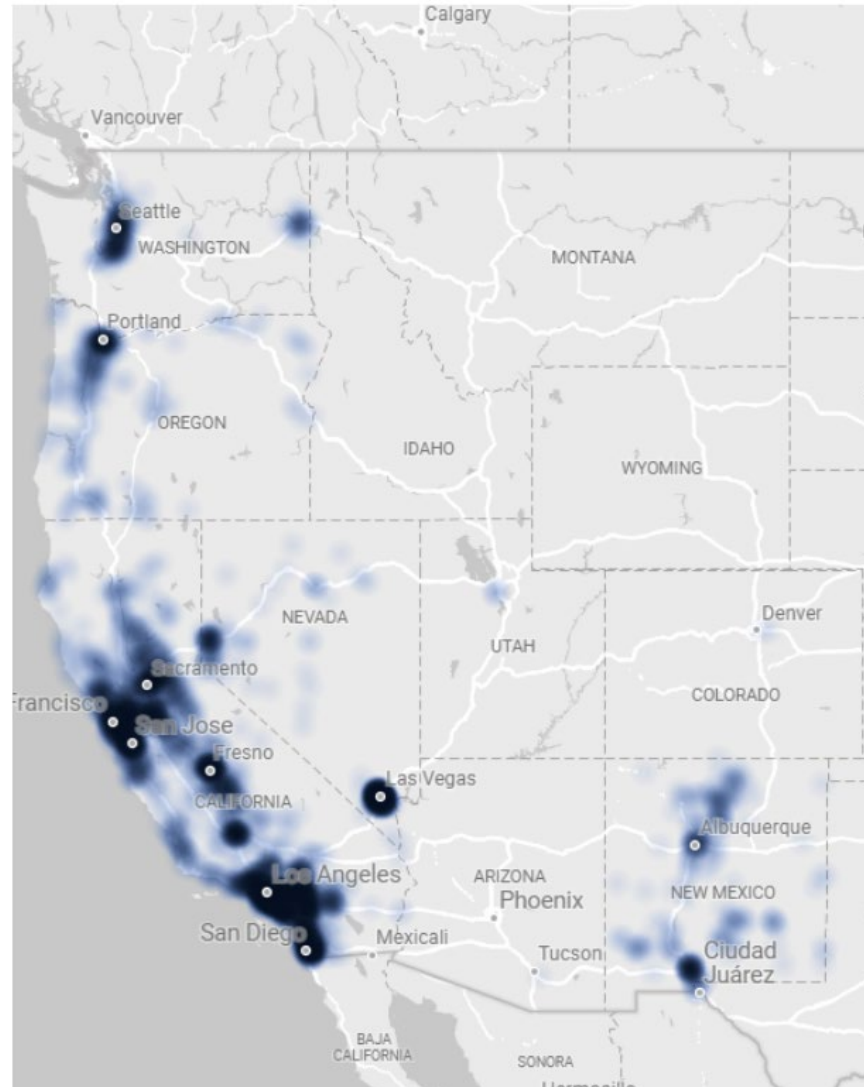

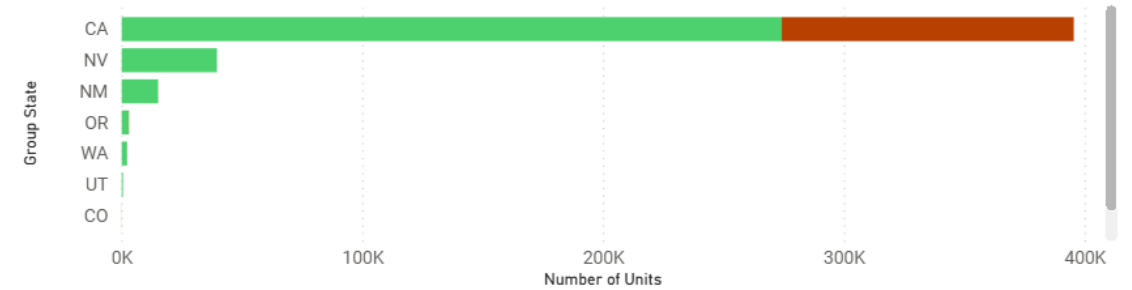
Distributed Generation Groups

Unit Nameplate (MW) by Zip Code



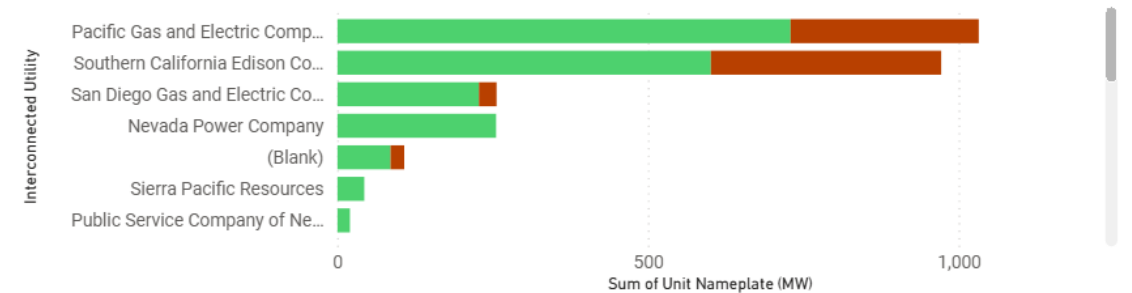
Count of Units

Unit Status ● Active ● Pending

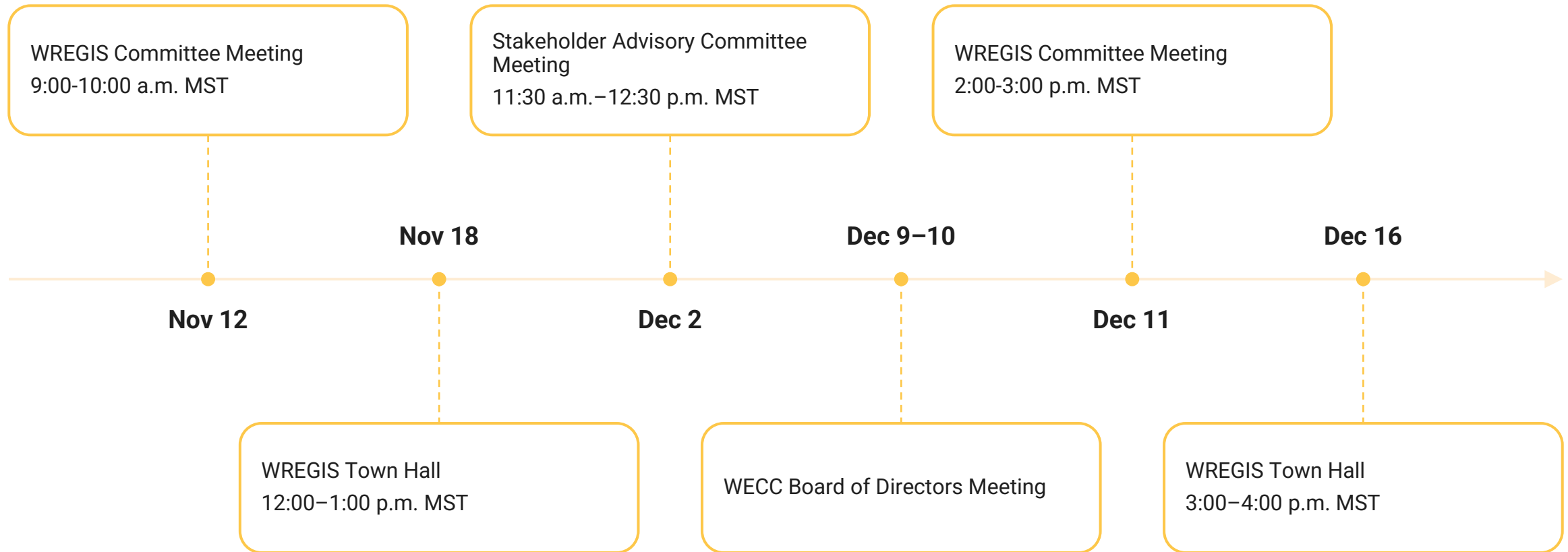


Unit Nameplate (MW) by Interconnected Utility
