#### May 14, 2025

#### 1. Welcome, Call to Order

Brian Theaker, Member Advisory Committee (MAC) Chair, called the meeting to order at 2:00 p.m. MT on May 14, 2025. A quorum was present to conduct business. A list of attendees is attached as Exhibit A.

#### 2. Review WECC Antitrust Policy

Brittany Huggins, Assistant Corporate Secretary, read aloud the WECC Antitrust Policy statement. The policy can be found on wecc.org.

#### 3. Approve Agenda

Mr. Theaker introduced the proposed meeting agenda.

#### 4. Review and Approve Previous Meeting Minutes

Mr. Theaker introduced the minutes of the meeting on March 11, 2025.

#### 5. Review Previous Action Items

There were no previous action items to report.

Mr. Theaker thanked Branden Sudduth, Vice President Reliability Planning and Performance Analysis, on his presentation on behalf of WECC on the 2025 Summer Reliability Outlook at the May 2, 2025 California Joint Energy Summer Reliability workshop. He closed by commenting on today's agenda items including two of MAC's main responsibilities on providing recommendations for the Business Plan and Budget (BP&B) and director compensation, thanking everyone involved for their hard work in preparing the recommendations.

#### 6. MAC Budget Subcommittee Update

Mr. Dunckel, MAC Budget Subcommittee (MBS) Chair, provided an overview of the WECC 2026 BP&B and presented the MBS recommendations. The MAC asked questions about public comments received and reserve levels.

#### On a motion by Dale Dunckel, the MAC approved the following resolution:

Resolved, that the Member Advisory Committee adopt the MAC Budget Subcommittee's 2026 Business Plan & Budget Recommendations dated May 1, 2025.

### 7. Nominating Committee Update

Duncan Brown, Class 3 Nominating Committee (NC) member, provided an update on NC discussions and the subsequent recommendation for 2026 director compensation.

#### On a motion by Duncan Brown, the MAC approved the following resolution:

Resolved, that the Member Advisory Committee (MAC), acting on the recommendation of the Nominating Committee (NC), at the meeting of the MAC on May 14, 2025, approves 2026 Director compensation, effective January 1, 2026, as follows:

- Annual Director retainer be increased by 7.3% from \$107,500 to \$115,373;
- Annual WECC Board Chair premium to remain at \$25,000; and
- Annual premia for WECC Board Vice Chair and WECC Board Committee Chairs to remain at \$10,000.

#### 8. Section 4.9 Work Group Update

Chris Parker, Vice Chair, provided an update on Section 4.9 Work Group activities and next steps. The work group has drafted Bylaw revisions, and draft revisions will be posted for public comment by May 23, 2025. Mr. Parker will work with the MAC on drafting MAC recommendations and comments on the Bylaw revisions.

#### 10. Public Comment

No public comments were made.

#### 11. Roundtable
