1. Welcome, Call to Order

Brian Theaker, Member Advisory Committee (MAC) Chair, called the meeting to order at 2:00 p.m. MT on February 5, 2025. A quorum was present to conduct business. A list of attendees is attached as Exhibit A. Brittany Huggins, Assistant Corporate Secretary, served as minute taker.

2. Review WECC Antitrust Policy

Ms. Huggins read aloud the WECC Antitrust Policy statement. The meeting agenda included a link to the posted policy.

3. Approve Agenda

Mr. Theaker introduced the proposed agenda.

On a motion by Brian Theaker, the MAC approved the agenda.

4. Review and Approve Previous Meeting Minutes

Mr. Theaker introduced the minutes from the meeting on December 10, 2024.

5. Review Previous Action Items

There were no previous action items to review but Ms. Huggins noted that the MAC Resource Guide was drafted and being reviewed by WECC Communications and would be distributed to the MAC before being posted on wecc.org.

6. MAC Leadership Remarks

Mr. Theaker commented on the tragedy of the Los Angeles fires, the new administration and potential policy changes, and gratitude for the strong governance of WECC and confidence in the commitment of the MAC, Nominating Committee (NC), and MAC Budgets Subcommittee (MBS) in continuing the necessary work.

7. Member Advisory Committee Charter

Mr. Theaker summarized revisions to the MAC Charter and thanked WECC legal staff for their review. Ms. Huggins addressed recent edits to the charter, including removal of reference to "subclass(es)" and specific bylaws sections. Mr. Theaker addressed concerns around language that a special meeting could be called with a 3-day notice. He commented that the MAC rarely calls for a special meeting and if there was ever a need, he and WECC staff would work to provide as much notice as possible.

On a motion by Linda Jacobson-Quinn, that MAC, recommended for Board approval the revised MAC charter.

8. Western Assessment of Resource Adequacy

Vic Howell, Director of Reliability Assessments and Modeling, Matt Zapotocky, Senior Reliability Assessments Engineer, and Katie Rogers, Reliability Assessments, presented on the 2024 Western Assessment of Resource Adequacy (Western Assessment), including reliability risks, load growth, resource additions and retirements, and variability and a sensitivity analysis. The MAC discussion included concerns about demand growth, (specifically for data centers and A.I.), resource adequacy, weather challenges, and changes due to new administrations.

9. Section 4.9 Review Discussion

Jeff Droubay, Vice President and General Counsel, provided a section 4.9 Review Work Group update and focused on MAC discussion and feedback concerning the proposal to eliminate a 4.9 review. Mr. Droubay summarized WECC's evolution from a trade association, to a regional entity and RC, to a regional entity. He highlighted the many checks and processes in place to ensure WECC and the Board is continuously evaluating its effectiveness in fulling its delegated functions. He responded to questions about Bylaws historical background, possible future bylaws revisions, timing and nimbleness of future governance reviews without a 4.9 review, and MAC's scope in raising future issues. Some MAC members voiced concerns on the proposal to remove Section 4.9. Mr. Droubay closed by confirming that the Section 4.9 Work Group is working on the bylaws revisions and the MAC will have additional opportunity to provide feedback on the full bylaws revision.

10. Work Group and Liaison Reports

a. Nominating Committee, Duncan Brown, liaison, provided an update on NC activities.

- d. Resource Adequacy Advisory Group (RAAG), Mr. Theaker had no update.
