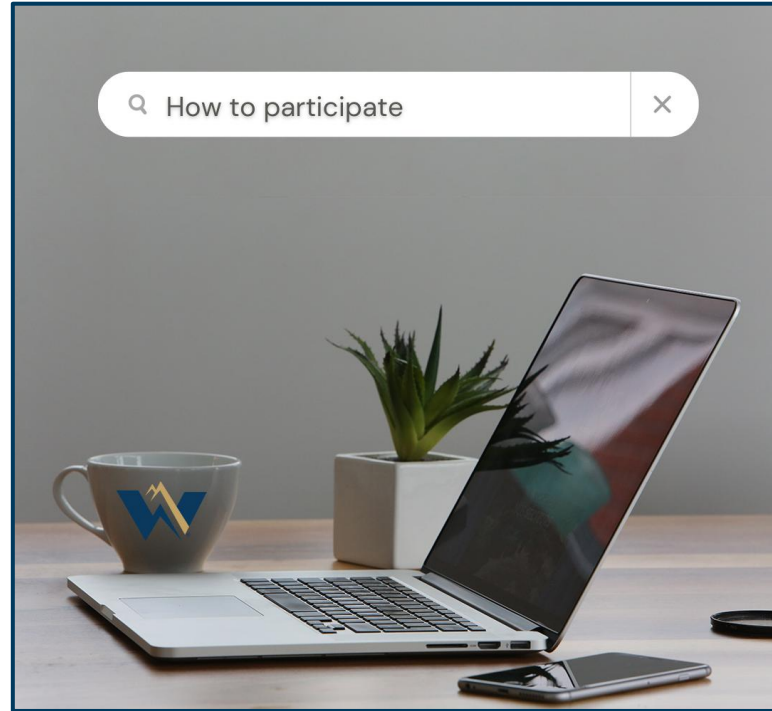

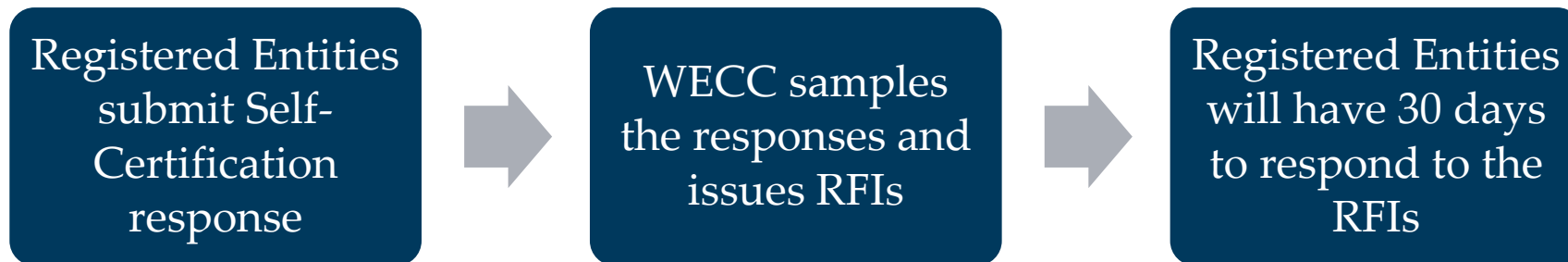

Self-Certification Scopes

Self-Certification scopes were driven by Reliability Risk Priorities as applicable to entities based on registration and monitoring and enforcement history

Next Steps

- WECC will issue RFIs to a subset of Registered Entities that responded “Compliant” to understand internal controls and processes the entity uses to mitigate risks associated with the applicable Standards
- Sampling will be done pursuant to the ERO Sampling Handbook guidelines
