1. Welcome, Call to Order

Chris Leyerle, WREGIS SAC Chair, called the meeting to order at 11:31 a.m. MT on April 1, 2025. A quorum was present to conduct business. A list of attendees is attached as Exhibit A.

2. Review WECC Antitrust Policy

JB Brander read aloud the WECC Antitrust Policy statement.

5. WREGIS Staff—Updates

JB Brander informed the WREGIS SAC of the following items:

- System functionality updates—
 - WREGIS's software vendor completed migration to Amazon Web Services (AWS) last weekend. This should increase system efficiency.
 - The first round of testing has been completed for a system enhancement release scheduled for later this month.
- User trainings—
 - Two online trainings were held in March; 100+ users participated. WREGIS plans to continue trainings through 2025 and will notify applicable users when those are scheduled.
 - WREGIS has scheduled an all-day, in-person training for Generator and General Organization Types on April 23, 2025, in Salt Lake City. No virtual version of this training will be available; however, topics may be covered in future online trainings.

 WREGIS completed testing of critical features in advance of upcoming Program deadlines. A participant suggested a standing agenda item for Distributed Generation Group (DGG) information. It was determined that when there is a specific topic related to DGG, members send it to the SAC chair in advance for inclusion on the agenda instead.

A question was raised about how to register hybrid generation resources with batteries behind the meter. J. Brander gave a brief overview of how hybrid resources are handled at WREGIS.

A participant asked whether they could use data monitoring software to determine generation amounts. J. Brander advised the use of inverters for metering is outlined in the WREGIS Operating Rules.
