Subject: Member Advisory Committee Class 3 Nomination

Dear Class 3 Member Representative,

The Member Advisory Committee (MAC) serves an important role in advising the WECC Board of Directors (Board). MAC responsibilities include giving timely updates and communications to the membership, helping to select Board of Director candidates, setting Board Director compensation, developing a work plan that includes consideration of issues identified by the Board and the MAC, and representing the interests of their member classes as the MAC considers issues.

The MAC is seeking nominations for a Class 3 representative. Two positions will be open for election—the seat previously held by **Brian Theaker** and the current seat held by **Mike Riley**, interim Class 3 representative (**this seat will be for the remaining 1-year vacant term + 3 years**). The Class 3 MAC representative whose term is not up for election this year is **Tatyana Grant**.

For nominating and electing MAC members, the MAC Charter requires that:

- Only members of each class may nominate and vote on candidates for election as MAC member representatives for their respective class.
- A class candidate need not be a member of the class, nor an employee of a class member.
- A quorum (constituting a majority of the members of a class) must be achieved to elect a MAC member for the class; election shall be by simple majority of votes cast.

In accordance with these requirements, please submit any nominations for a Class 3 MAC representative. Each nominee must complete, sign, and date the attached Candidate Statement of Qualifications (CSQ). The Nomination and Election Process is as follows:

- July 27, 2026—Final submissions due
- July 30, 2026—Slate of nominees will be posted on WECC.org Announcements page and sent via WECC Weekly
- August 3, 2026—Ballots sent to Member Representatives
- August 28, 2026—Voting concludes
- September 15, 2026—Election results will be announced at the open board session.
