### 1. Welcome, Call to Order

### 5. NW Hydro Hybrid Year

Dan Broman, Pacific Northwest National Library (PNNL), presented PNNL's Hydro Hybrid Year, which evaluates the water conditions specific to the Northwest using the 2034 Anchor Data Set (ADS). The PCDS suggested including this in the 2036 ADS and suggested developing a scenario to reflect the resulting changes in the hydro unit data for the 2034 ADS Production Cost Model (PCM).

**On a motion by Anders Johnson, the PCDS approved the NW Hydro Hybrid Year recommendations.**

### 6. 2034 ADS PCM

J. Jensen provided an update on the 2034 ADS. WECC is collaborating with PNNL to make updates to ensure compatibility with C-PAGE. J. Jensen mentioned there is some unserved load

that he is working on relieving. J. Jensen will create a list of C-PAGE issues that were seen during the past cycle to ensure they are addressed during this upcoming cycle.

## 7. 2036 ADS PCM

J. Jensen provided an update to the 2036 ADS PCM: generator alignment between the 2036 heavy summer (HS)1 power flow (PF) and the 2025 loads and resource (L&R) data is underway. The stakeholder updates are being implemented. The expected publishing date is March 1. The PCDS suggested analyzing the PF, identifying by area what type of capacity and how much is being added, followed by comparing it with the 2025 L&R. A suggestion was made to work on the retired generations going backwards from 2036. J. Jensen will test the latest version of PSLF with GridView (GV).

## 8. Solar and Wind PTCs

Solar and Wind Production Tax Credits (PTC's) will be reviewed during the next meeting.

The PCDS would like to begin meeting weekly following the February 18 meeting.
