

Standard Authorization Request WECC-0153 Review and Update INT Consolidated Criterion (ICC) Five-year Review

### **Overview**

This Standard Authorization Request (SAR) was: 1) received on July 26, 2023, 2) deemed complete the same day, 3) and approved by the WECC Standards Committee August 9, 2023.

### Introduction

On March 7, 2023, the WECC Standards Committee (WSC) created the INT Consolidation Criterion (ICC) by consolidating all as-approved and in-effect WECC INT-related Criteria into a single document (ICC).

Because the 11 consolidated INT CRTs have various review dates, this request resets those dates to a single date five years after the ICC is approved by the WECC Board of Directors (Board). That date is estimated to be Q2 2029. (See the below chart for a listing of the 11 documents.)

If approved by the Board, the 11 separate INT CRTs will be removed from the WECC Approved Regional Criteria accordion and replaced with the single ICC document.

This project does not preclude an interim SAR prior to the 2029 date, if deemed necessary by a SAR author.

### Goal

Because the Procedures require each WECC CRT to be reviewed each five years, WECC has had at least one INT-related drafting team actively and continuously reviewing the below documents for over a decade. By creating the ICC, a single team can review the full spectrum of the documents once each five years.

# Standard Authorization Request WECC-0153 INT Consolidation Criterion Five-year Review

### Scope

The entire ICC is open for review in order to reset the entire document to a single five-year review date.

Because much of the ICC has been recently reviewed, it is suggested that this project primarily focus on those portions of the ICC requiring review in 2024/2025.

### **Definitions and Standardized Terms**

Because the ICC was drafted over the course of multiple years by multiple drafting teams, defined and common terms are not used consistently. The drafting team should review the ICC and standardize terms throughout. For example, the "WIT" is sometimes referred to as the WECC Interchange Tool, and other times it is referred to as the Western Interchange Tool. The review goal would be to create consistent verbiage throughout.

### **Numbering Reset**

The ICC incorporates all INT-CRTs as listed above.

Because various INTs have been retired or consolidated over time, the 11 INTs incorporated are not numbered sequentially. For example, INT-"002"-CRT-WECC no longer exists. This sequential void could lead to confusion on the part of new and future entrants to the industry. To remedy the concern, the drafting team should consider whether this is an appropriate time to sequentially renumber the segments of the ICC.

If this approach is adopted, the history table could include a cross-reference from old to new.
